SUMMARY

Offer Price and Net Proceeds from the Share Offer

- The Offer Price has been determined at HK\$0.53 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.53 per Offer Share and 100,000,000 Shares offered by the Company, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting fees and commission and estimated expenses paid and payable by the Company in relation to the Share Offer, are estimated to be approximately HK\$19.1 million. The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Net Proceeds from the Share Offer” below in this announcement and the section headed “Statement of Business Objectives and Use of Proceeds” in the Prospectus.

The Public Offer

- The Public Offer Shares initially offered under the Public Offer have been significantly over-subscribed. A total of 20,880 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** service (www.hkeipo.hk) for a total of 1,013,352,000 Public Offer Shares, representing approximately 101.3 times of the total number of 10,000,000 Public Offer Shares initially available for subscription under the Public Offer.

The Placing

- The Placing Shares initially offered under the Placing have been slightly under-subscribed, representing approximately 0.9 times of the 90,000,000 Placing Shares initially available for subscription under the Placing. As the Public Offer Shares are over-subscribed, the reallocation procedures as described in the section headed “Structure and Conditions of the Share Offer — The Public Offer — Reallocation” in the Prospectus have been applied. The Sole Bookrunner has exercised its right to reallocate 8,596,000 Offer Shares, representing approximately 8.60% of the total number of Offer Shares initially offered under the Share Offer, from the Placing to the Public Offer to satisfy excess demand under the Public Offer.
